# Academic Year Highlights

## Batch IV PGDIT Internship

The Internship for the Batch IV students started on 15<sup>th</sup> December 2003. Over 20 companies participated with on-campus and some off-campus selection. Companies like ABB, Alopa, Tejas and TI participated for the first time this year. Some of the companies like Covansys, Mastek and MindTree offered internship with placement offers.



## Batch V PGDIT

The orientation for the batch of 148 students started on August 16, 2003 and the Fall Semester classes commenced on August 18, 2003 in the new campus. The semester was completed by mid December followed by the December vacation. Spring Semester started on January 5, 2004 and lasted till end of April 2004.

Hostel facilities were provided at our new Electronics City campus. Health insurance coverage, library and other resources were also provided as in earlier academic years.

## Batch VI PGDIT

The admission process started for Batch VI with the Admission notification in the newspapers in November 2003. The Entrance Test was conducted on March 14, 2004 at a total of eight centers this year. The interviews for short-listed candidates were held at iiit-b on May 5-7, 2004.

The Fee Structure has been maintained with a Tuition Fee of Rs. 50,000/- per semester, and other customary charges for Hostel, Mess and Caution Deposits. Student Scholarships were also available as in earlier years.

## Curriculum

The Post Graduate Program in Information Technology (PGPIT) is a four-semester broad-based program in IT going beyond traditional computer science. Apart from imparting technical knowledge, the program provides the managerial skills that are essential in today's knowledge-dominant world.

With the expansion of regular faculty and diversification of visiting faculty, the curriculum and course offerings underwent substantial change for the Batch V students. The Spring Semester course offerings were, in particular, expanded to reflect the changing technology and industry needs, and the availability of special visiting faculty from the industry.

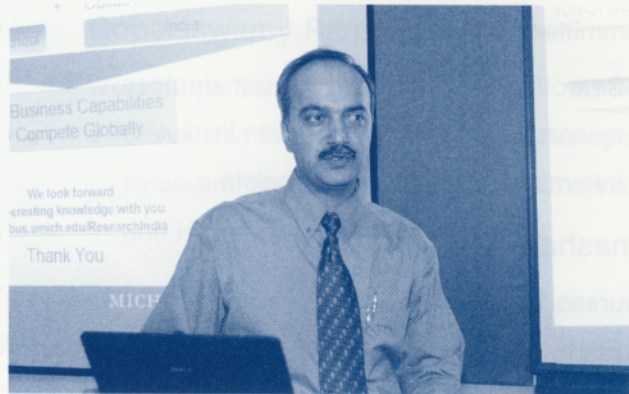

As the Internet is beginning to be seen more as a collection of services rather than a collection of pages, the issue of coordination is likely to become more and more acute in the coming years.

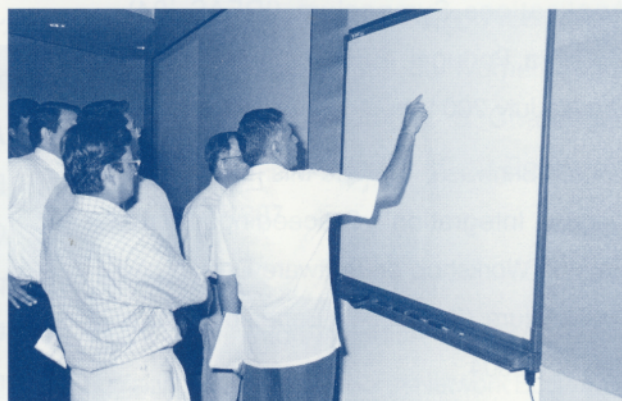

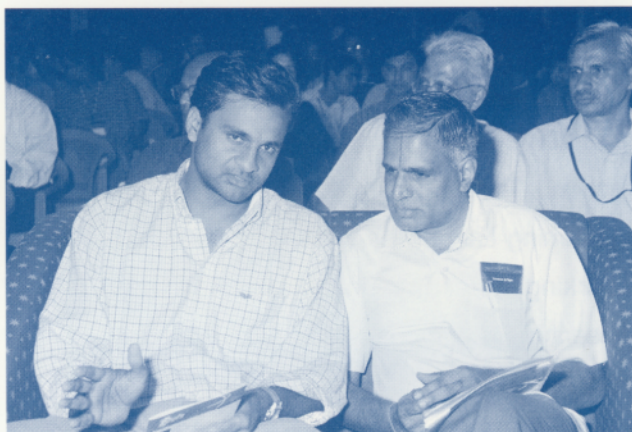

# Auditor's Report

1. We have audited the attached Balance Sheet of Indian Institute of Information Technology–Bangalore (hereinafter referred to as the Institute) as at 31<sup>st</sup> March 2004 and the Income and Expenditure Account for the year ended on that date, annexed thereto. These financial statements are the responsibility of the Institute. Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with the auditing standards generally accepted in India. **Schedule T: Significant Accounting Policies & Notes forming  
part of accounts for the year ended March 31, 2004**

**Significant Accounting Policies:**

1. **Basis of Preparation:** The financial statements have been prepared under the historical cost convention and the accrual basis of accounting, and in accordance with generally accepted accounting principles and standards.
2. **Capital Grants:** Grants received from Government of Karnataka for the purpose of initial setting up capital expenditure of the institute, and Corpus Donations received from others towards Capital Expenditure of the institute is grouped under Capital Grants. Grants received from Government of Karnataka and others towards meeting the initial capital expenditure in setting up Hubli Branch of iiitb is also shown under Capital Grants.
3. **Revenue Grants:** Donations/Grants received without the stipulation that only the Income Earned to be utilised for the purpose of institute, and which are not towards any Capital Expenditure are shown under Revenue Grants.
4. **Earmarked Fund:** Donations/Grants received with a stipulation that only the Income Earned to be utilized for the purpose of institute are shown under Earmarked Fund.
5. **Fixed Assets:** Fixed Assets are shown at Cost of acquisition, which includes taxes, duties and other related direct expenses Less Depreciation.
6. **Capital Work in Progress:** Capital Work in Progress includes cost of fixed assets that are not ready for their intended use and also includes advances paid to acquire fixed assets.
7. **Depreciation:** Depreciation on fixed assets has been provided on written down value method at the rates specified in the Fixed Assets Schedule. Additions to fixed assets during the year have been depreciated on pro rata basis from the date of capitalisation. Deletions to fixed assets during the year have been depreciated on pro rata basis up to the date of deletion/sale.
8. **Foreign Currency Transactions:** Grants received / expenditure incurred in foreign currency are recorded at the Exchange Rate at which these transactions are settled.
9. **Income Tax :** The institute has been registered as a Charitable Institution under Section 12A of the Income Tax Act, 1961. Hence the Income of the institute is exempt from payment of tax subject to fulfillment of conditions therein. Hence no provision for income tax is being considered in the books of account of the Institute.
10. **Library Expenses:** Library Expenses incurred towards subscriptions and towards purchase of books are expensed in the year of payment itself since these books become outdated in view of the fast emerging technological changes
11. **Preliminary Expenses:** Preliminary Expenses are amortised over a period of 10 years commencing from the year in which the Institute commenced its operations.
12. **Staff Retirement Benefits:** The Institute contributes to Statutory Provident Fund Scheme (A defined contribution retirement plan) for all its employees. Provident Fund dues are recognised when the liability to contribute to the Provident Fund arises under the Provident Fund Act.

The liability for Gratuity has been recognized in the books of accounts as stipulated under the payment of Gratuity Act, 1972.
